#### **LELAND BENCH UTILITIES | 1711-271**

Work on this project over the next few weeks will include working with Vince Memmott with Uintah Advantage about final demands required by the power, water, and gas utilities. Monthly updates are scheduled with Uintah Advantage to go over technical questions and update design parameters.

Our team is working with Bowen Collins (BCA) to define the water pipeline engineering scope assignments. BCA is a carry-over from work previously completed in the area. Our team is working with the Uintah Water Conservancy District and the Ouray Park District to develop supply arrangements.

Ongoing discussions with utility providers including Moon Lake Electric, and the Ute Tribe are needed to determine the best options for the power line and who would be provided the power to the area.

The Gas and Water utility projects will be treated as additional phases for this overall project. Concept planning is underway to review scope, schedule, and cost for each utility.

- Determine Natural Gas Line Corridor and Alignment
- Update project design criteria for each utility. Coordinate with Uintah Advantage for Demands
- Transmission Power Decision
- Ongoing Discussions with Tribe and other providers.
- Consider withdrawal of CIB application for electrical power.

Estimated Budget <\$7,000

This project will continue to be a primary focus over the next month.

#### Uinta Basin Rail Line | 1803-227

The Rail project has been driving the primary work for the last few weeks. It would take several pages to describe the ongoing activities for this project.

The CIB meeting for funding on the \$27.9M request regarding the rail is scheduled for Thursday November 8th. We look forward to positive results. The Coalition received proposals from 2 great engineering firms to complete the engineering and related work. A selection will be made during Board meeting.

We received proposals from two aerial companies last week. We will be reviewing them and moving forward with target layout design over the upcoming weeks, hopefully completing a portion of the mapping prior to snowfall.

Our team has been working on alignment segments along the overall alignment just east of the existing DGNT rail line as well as the alignment through tribal land.

The project team will be working with Director McKee as we look to bring in other consultants to assist with design, environmental, and revenue generating analysis for the project as laid out in the CIB application.

Project is a priority focus.
