NOTICE IS FURTHER GIVEN that the Governing Board calls a public hearing for the purpose of inviting public comment on the proposed 2019 Budget and the economic impact the budget will have on the private sector. The public hearing will be held on December 14, 2018, at 10:00 a.m., or as soon thereafter as feasible, at the regular meeting place of the Coalition at the Carbon County Commission Chambers, located at 751 East 100 North, Price, Utah 84501. The Governing Board directs the budget officer to cause notice of the public hearing to be published (1) one time in a newspaper of general circulation in one of its member counties at least seven days prior to the date of public hearing, and (2) on the Utah Public Notice Website at least seven days prior to the date of the public hearing. The Coalition has no taxing powers and accordingly no tax increase is or can be made in connection with the 2019 budget.

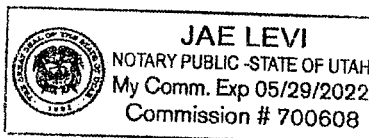
