Resolution No. 2020-12B

**RESOLUTION SUSPENDING THE EIS EFFORT ON THE EASTERN UTAH
REGIONAL CONNECTOR PROJECT AND RELATED MATTERS.**

WHEREAS, the Coalition has received funding for the EIS on the Eastern Utah Regional Connector project to extend a paved highway between I-70 in the Cisco area and the Uintah Basin to connect to the Seep Ridge Road; and

WHEREAS, to advance the environmental study on the Eastern Utah Regional Connector project (extend Seep Ridge Road to I-70) (EURC) the Coalition entered into various contracts with the Bureau of Land Management (BLM), Tetra Tech, CIVCO and others; and

WHEREAS, the Coalition has evaluated the challenges and concerns related to the EIS for the EURC and at this time has determined it would be best to suspend the work on the EIS:

NOW, THEREFORE, be it resolved by the Governing Board of the Seven County Infrastructure Coalition, Utah as follows:

1. The Governing Board hereby approves the suspension of work on the EIS related to the EURC and directs the Executive Director to coordinate with the contracted parties to reach a reasonable point in their work at which they can provide a summary of the work completed and to then cease further work on this EIS.
2. All parts of this Resolution are severable, and if any section, clause or provision of this Resolution shall, for any reason, be held to be invalid or unenforceable, the invalidity or unenforceability of any such section, clause or provision shall not affect the remaining sections, clauses or provisions of this Resolution.
3. All resolutions or parts thereof in conflict herewith are, to the extent of such conflict, hereby repealed and this Resolution shall be in full force and effect immediately upon its approval and adoption


