

**AGREEMENT TO EXTEND TIME TO EXERCISE RIGHT-OF-WAY EASEMENT(S)
OPTION**

By agreement dated as of December 28, 2018, by and among Don Hicken Farms, LLC, a Utah limited liability company at 3850 E. 1750 N., Roosevelt, Utah 84066 ("Grantor") and the Seven County Infrastructure Coalition, an independent political subdivision of the State of Utah ("Grantee"), the Grantor granted Grantee an option to purchase right-of-way easement, which option was signed and notarized, and evidence of the option was recorded with the Uintah County Recorder as Entry No. 2019000476, Book 1594, Pages 81-85 ("Easement Option"). The right-of-way easement described in the Easement Option is referred to herein as the "Easement." Grantor and Grantee may be referred to herein collectively as the "Parties" and individually as a "Party."

Based on the terms herein, as of January 2, 2024, Grantor hereby extends the Easement Option and Easement to the Grantee for a period of five (5) years until January 2, 2029.

EXTENSION OF RIGHT-OF-WAY EASEMENT OPTION.

For the sum of \$10.00 and other good and valuable consideration Grantor hereby extends to Grantee the time to exercise the Easement Option until January 2, 2029. The future purchase price for the Easement Option will be negotiable between the Parties, which future negotiated price will supercede and replace the purchase price set forth in paragraph 3 of the original Easement Option. All other terms and conditions of the Easement Option and Easement are hereby referenced and incorporated as if stated herein, such that the Easement as recorded is effective between the Parties until the end of business on January 2, 2029. 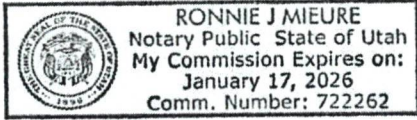
